RESOLUTION OF THE OAKDALE PLACE HOMEOWNERS ASSOCIATION REGARDING PROCEDURES FOR ADOPTION OF POLICIES, PROCEDURES, RULES, REGULATIONS, AND GUIDELINES

SUBJECT:

Adoption of a policy and procedure to be followed when adopting policies, procedures, rules, regulations or guidelines (hereinafter "Policy" or "Policies") regarding the operation of the Association.

PURPOSE:

To adopt a standard policy and procedure to be used in developing Policies in order to facilitate the efficient operation of the Association.

AUTHORITY:

The Declaration, Bylaws, and Articles of Incorporation of the Association and Colorado law.

EFFECTIVE DATE:

APRIL 9 2014

RESOLUTION:

The Association hereby adopts the following policies and procedures to be followed in adopting Policies of the Association:

- 1. <u>Scope</u>. The Board of Directors of the Association may, from time to time, adopt certain Policies as may be necessary to facilitate the efficient operation of the Association, including, but not limited to, the clarification of ambiguous provisions in other documents, or as may be required by law.
- 2. <u>Drafting Procedure.</u> The Board shall consider the following in drafting the Policy:
 - (a) whether the governing documents or Colorado law grants the Board the authority to adopt such a Policy;
 - (b) the need for such Policy based upon the scope and importance of the issue, and whether the governing documents adequately address the issue; and
 - (c) the immediate and long-term impact and implications of the Policy.
- 3. <u>Adoption Procedure</u>. Upon adoption of a Policy, the Policy or notice of such Policy, including the effective date, shall be provided to all Owners by any reasonable method as determined in the sole discretion of the Board, including, but not limited to, posting on the Association's website.
- 4. <u>Policy Book</u>. The Board of Directors shall keep copies of any and all adopted Policies in a book designated as a Policy Book. The Board of Directors may further categorize Policies, Procedures, Rules and Regulations, Resolutions and Guidelines, but shall not be required to do so.

- 5. <u>Definitions.</u> Unless otherwise defined in this Resolution, initially capitalized or terms defined in the Declaration shall have the same meaning herein.
- 6. <u>Supplement to Law.</u> The provisions of this Resolution shall be in addition to and in supplement of the terms and provisions of the Declaration and the law of the State of Colorado governing the Community.
- 7. <u>Deviations</u>. The Board may deviate from the procedures set forth in this Resolution if in its sole discretion such deviation is reasonable under the circumstances.
- 8. <u>Amendment</u>. This Procedure may be amended from time to time by the Board.
